Frequently Asked Questions

Q: Does LCCU charge a fee for account statements?

A: We charge no fee for e-statements or for sending statements to members through the mail. However, if members request a copy of their statement at the branch, there is a \$2 fee.

Q: If I receive my statements in the mail, can I still access my e-statements online?
A: Members who have not signed up for e-statements can still view their statements from the last 12 months through the online access portal. Members who have signed up for e-statements can view their statements from the last 18 months through our online access portal.
